

## A word from the Chairman of the Board

Over the years, a dynamic artificial intelligence ecosystem has been established in Quebec, one that benefits from the expertise of specialized AI players who are involved along the entire value chain, wherein all stakeholders work closely with each other. These major assets are the envy of many and lend a unique aspect to our ecosystem.

The Quebec and Canadian governments' actions and investments have played a major role in structuring this ecosystem. For instance, the creation of the AI Cluster Steering Committee by the Ministère de l'Économie et de l'Innovation (MEI) in 2017 was the first milestone in the development of a coordinated AI ecosystem in Quebec where stakeholders act in synergy for the collective good.

Forum IA Québec was launched in 2020 and represented the second major milestone in the effort by ecosystem players to mobilize around common goals. For a year now, the Forum has been working, with the financial support of the MEI, to improve the ecosystem's access to the talent it needs and support AI appropriation by organizations in various industries, in addition to showcasing Quebec's AI successes, conducting strategic reflection activities, and supporting the Quebec government for some key projects.

The wealth of expertise in the field and the strong collaboration of ecosystem players in the initiatives described in this report do not mean that the game is won. As Quebec moves forward in the production and use of AI, other nations are looking to increase their competitive advantage in this key area by stepping up their game.

Quebec will succeed in making AI the foundation of its future prosperity by continuing to target investments in key sectors and leveraging the strength of its AI ecosystem.

And Forum IA Québec will continue to act as a catalyst for the AI ecosystem and increase the positive impacts of this technology on Quebec's prosperity.



The Forum supported the Ministère de l'Économie et de l'Innovation in its call for large-scale AI projects. It also collaborated with the Observatoire international sur les impacts sociétaux de l'AI et du numérique (OBVIA) in the start-up of a project to stimulate the adoption of AI in the agri-food sector.

Throughout the past year, the Forum has stayed tuned in to ecosystem actors endeavoured to remain agile to find effective solutions to the challenges encountered.

At the end of its first year of operation, the Forum is well positioned to fully play its role as a federator of all AI driving forces in Quebec. The actions carried out over the last few months will contribute to the development and use of AI in Quebec and, consequently, to the increase of our collective wealth.



## Forum IA Québec activities

To better serve the Quebec AI ecosystem, Forum IA Québec aligns its activities using three strategic directions and eight approaches.



## 2020-2023 Strategic Plan

During 2020, the Forum undertook a large-scale virtual tour of the ecosystem to listen to the concerns of its stakeholders and update the findings formulated in May 2018 in the *Strategy for the Development of Quebec's Artificial Intelligence Ecosystem*.

Based on this consultation, the Forum developed and adopted a 2020-2023 Strategic Plan with three strategic directions and eight strategic approaches to guide its actions.

#### **Strategic directions**

### Strategic approaches



#### 1. CONCERTATION

Promote concerted action by local stakeholders and their mobilization around common projects

- **1.1** Ensure the **cohesion**, **collaboration**, and **cooperation** of artificial intelligence stakeholders in Ouebec.
- **1.2** Facilitate access to information on the resources available to the actors of the AI ecosystem and promote their networking, specifically through a **common showcase**.



## 2. STRATEGIC THINKING AND MONITORING

Conduct strategic thinking and monitoring activities

- **2.1** Carry out **a talent watch** to align the needs of the ecosystem, the job profiles of the future and the training offering, while facilitating a better link between job supply and demand.
- **2.2** Put in place mechanisms to enable the ecosystem to **assess its performance** and **adjust** quickly and nimbly to scientific advances, the emergence of new players and the evolution of international best practices.
- **2.3** Help accelerate the **development and adoption of AI solutions** by the entire Quebec economic fabric and promote the **emergence of Quebec's flagship AI companies.**
- 2.4 Help the ecosystem leverage AI to tackle major societal challenges and position Quebec as a leader in the production and use of AI in an ethical and socially responsible manner.



### 3. REPRESENTATION AND PROMOTION

Represent and promote the ecosystem in Quebec, Canada and abroad

- **3.1** Act as a **reflection-process partner** with the government to promote the adoption of a legislative framework and public policies that encourage the development of Quebec's AI ecosystem.





## **Our achievements**

During 2020-2021, the Forum undertook nine projects and participated in seven initiatives led by other players in the ecosystem.



#### STRATEGIC DIRECTION 1

#### Concertation

The aim of this first strategic direction is to encourage concertation between the players in the field and mobilize them around common projects. Two approaches guide this strategic direction.

#### 1.1 Concertation and mobilization

To ensure the cohesion, collaboration, and concerted action of AI actors in Quebec, the Forum's objective in 2020-2022 is to organize and participate in events that bring the community together, in addition to launching and leading three projects:

- Ecosystem's Common Showcase (launched in December 2020)
- Promotion of the Quebec AI ecosystem (launched in January 2021)
- Talent (launch coming in 2021-2022)

The projects are working groups that mobilize a dozen ecosystem actors. Each one acts as an advisory committee to help the Forum prioritize the projects to be launched and ensure their success.

The concertation and mobilization of the Quebec AI ecosystem involves the consultation and proactive involvement of stakeholders in the implementation of initiatives that will serve the community. The first two projects mentioned above have been launched and are currently working on identifying the functionalities and content that will be hosted on the Ecosystem's Common Showcase. The Talent project will be launched in 2021-2022.

Since its first year of activity, the Forum has participated in many events that bring together the community. In collaboration with various partners, it has been involved in the development of large-scale events to showcase Quebec's AI expertise.

### 1.2 Ecosystem's Common Showcase



#### Description

The Ecosystem's Common Showcase is both a project and a workstream, the latter allowing for consultation with stakeholders in the Quebec AI ecosystem to identify the functionalities that should be developed as a priority for this showcase.

This initiative aims to facilitate access to information on available resources and ongoing projects for the actors of the AI ecosystem and promote their connection, in particular through a common showcase, with various functionalities designed to meet the needs of end users.

STRATEGIC DIRECTION 2

## Strategic thinking and monitoring

The objective of this second stratetic direction is to identify the actions necessary to ensure the growth and sustainability of AI development in Quebec. It is broken down into 4 approaches.

#### 2.1 Talent

#### Creation of the MIFI expert committee, together with TECHNOCompétences



#### Description

The Forum assisted the Ministère de l'Immigration, de la Francisation et de l'Intégration (MIFI) in defining the main parameters of the Permanent Immigration Pilot Program for Artificial Intelligence, Information Technology and Visual Effects Workers by conducting consultations with ecosystem stakeholders and producing a document containing findings and proposals (e.g., regarding the minimum wage to be taken into consideration or the requirements to be established in terms of knowledge of French).

It also worked with TECHNOCompétences to define the process and rules to be put in place to determine whether an organization's application for an AI resource is admissible; to recruit the experts to sit on the committee responsible for advising the MIFI on each application; and to recruit the consultant responsible for supporting the work of the expert committee. The Forum developed the contractual agreement between the experts and TECHNOCompétences and continues to support the efforts of MIFI and TECHNOCompétences.

## Study on international best practices in AI training and knowledge transfer



#### Description

An international comparative study commissioned by the Forum and the PIA at CIRANO, OBVIA and EY aims to define the practices to adopt and the links to be put in place by the actors of higher education (colleges and universities) and the other actors of the Quebec AI ecosystem to improve AI training programs and promote knowledge transfer and collaboration between all AI ecosystem stakeholders.

#### Building and facilitating an AI researcher practice community



#### Description

The PIA (Pôle montréalais d'enseignement supérieur en intelligence artificielle) has commissioned several studies on the impact of the rise of AI on training in various sectors (e.g., nursing, management) at the college and university level, and on the needs to be met. The PIA and the Forum have brought together those responsible for these studies in a community to discuss ongoing projects.

### 2.2 Ecosystem performance

This approach focuses on setting up mechanisms that allow the ecosystem to assess its performance and adjust quickly and flexibly to scientific advances, the emergence of new players and the evolution of international best practices.

Always keeping its ear to the ground thanks to its many consultation activities and various projects, the Forum has been able to take the pulse of the ecosystem and use the knowledge acquired to guide its actions.

The Forum's goals in this regard are spread out over 2021-2022. More projects will be part of this approach in the coming year, including the launch of a study on the economic and social impact of the *Strategy for the Development of the Quebec's AI Ecosystem* and the production of a Quebec index to measure the performance of the ecosystem.

### 2.3 Ecosystem appropriation and growth

#### Study on the potential of AI in the agri-food sector



#### Description

The International Observatory on the Societal Impacts of AI and Digital (OBVIA), in collaboration with the Forum and IVADO, co-organized a series of workshops on the potential of AI in the agri-food sector, as well as on measures to foster organizational shifts towards data and AI. The Forum is funding and supporting the drafting of a report outlining the findings and recommendations from this work.

#### Description

The AI Integration Community is a multi-stakeholder initiative whose mission is to "transform organizations and break down barriers to AI integration to develop the full potential of the Quebec economy by evolving best practices."

The Community takes the form of monthly meetings bringing together a dozen or so large organizations wishing to share their learnings from applied AI projects, particularly with regard to change management.

#### Description

The Fonds de recherche du Québec (FRQ) organize a monthly meeting led by the Chief Scientist of Quebec, bringing together some twenty actors – researchers, consensus-building organizations, research centres, companies, MSSS, MEI, SCT, etc. – concerned about the adoption of AI in the health field.

Four sub-working groups are led by the participants at this table:

- · Access to data
- Social acceptability
- Outreach and visibility
- Analysis of the recommendations of various reports

Le Forum is piloting a project on Artificial Intelligence in Québec's Life Sciences and Health Technology Sector (*Portrait des avancées de l'IA en sciences de la vie et technologies de la santé*) (see section 2.4: AI in the service of society), to raise awareness among policy makers of the potential impact of AI advances in health under this third sub-working group.

## Artificial Intelligence in Québec's Life Sciences and Health Technology Sector



#### Description

At the Rencontres IA et Santé mentioned in section 2.3 (Ecosystem appropriation and growth – Participation in the Rencontres IA et Santé des Fonds de recherche du Québec), the Forum is drafting a portrait of AI advances in LSHT in Quebec in collaboration with Jean-Pierre Perrault, Vice-Rector of the University of Sherbrooke. The process aims to:

- Demonstrate the potential contribution of AI to achieving the objectives of the Québec Life Sciences Strategy.
- Provide concrete examples of the potential effects of greater access to health data.

#### **STRATEGIC DIRECTION 3**

## **Representation and promotion**

This third strategic direction aims to optimize the representation and promotion of the ecosystem in Quebec, Canada and abroad. It is guided by two approaches.

### 3.1 Representation

#### Description

With this approach, the Forum wants to act as a reflection partner with the government to contribute to the adoption of public policies favouring the development of the Quebec AI ecosystem.

As mentioned in the Talent approach, the Forum guided the Ministère de l'Immigration, de la Francisation et de l'Intégration in setting up the *Permanent Immigration Pilot Program for Artificial Intelligence, Information Technology and Visual Effects Workers*. It also collaborated with TECHNOCompétences in defining the application assessment process and creating a committee of experts capable of conducting assessments.

The Forum also supported the SCT in the ecosystem consultation on the *Stratégie d'intégration de l'intelligence artificielle dans l'administration publique*, as detailed in the "Ecosystem appropriation and growth" approach.

Throughout its activities, the Forum provides expertise and plays a key role in linking the ecosystem with public authorities.

#### 3.2 Promotion

#### **Rencontres IA (AI Meetings)**



#### Description

In collaboration with the Board of Trade of Metropolitan Montreal and Scale AI, the Forum participated in the development of an event that highlighted the Quebec and pan-Canadian AI ecosystem. These two days of virtual sessions were a must for all players in the field and for companies looking to discover how and why to invest in AI. Numerous AI-producing organizations were able to benefit from a choice platform to make themselves known.

#### **Common narrative**



#### Description

The Promotion of Quebec's AI Ecosystem workstream aims to ensure the influence of the ecosystem in Quebec, Canada and abroad by developing a common narrative and tools to maximize its international visibility, attract foreign investment and talent, and promote the export of Quebec's goods and services.

This project allows the Forum to consult the stakeholders of the Quebec AI ecosystem to identify the promotional content that should be developed as a priority and uploaded to the AI Ecosystem's Common Showcase.



### **Outlook for the future**

After its first year of existence, the Forum has already achieved many of the targets it set itself in its 2020-2022 Action Plan. It is well on its way to achieving all its objectives, and the upcoming year will be just as busy.

Several projects are in the preparation stage. The Forum plans to participate in the *Stratégie québécoise de la recherche et de l'innovation 2022* consultations and *Stratégie québécoise des sciences de la vie* update.

The Forum also plans to launch its third "Talent" project, focusing on labour issues in the sector.

Strengthening Quebec's position in AI also requires a better understanding of the Quebec environment. To this end, two studies are planned to assess the ecosystem's performance.

The Forum intends to work with the Secrétariat du Conseil du trésor and Ministère de l'Économie et de l'Innovation to become a privileged partner of the Government of Quebec and promote the adoption of public policies that foster the growth of Quebec's AI ecosystem and the productivity of Quebec organizations.

In the wake of the Ecosystem's Common Showcase workstream, promotional tools and a common narrative will be developed. A first iteration of this showcase should be available next winter.
